WHAT IS THE GOVERNANCE MODULE?



Easily accessible at all times through the ArkAngel risk management platform, the Governance Module dashboard focuses on the asset properties of your organization and the vulnerabilities that are discovered continuously. It helps you understand what your current security posture is, how it can evolve over time and how you can lower your cybersecurity risk in line with your business objectives.

The Governance Module is based on the 20 Critical Security Controls (CSC) developed by the Center for Internet Security (CIS). The controls represent high-priority, highly effective defensive actions that provide a "must-do, do-first" starting point for organizations seeking to improve their cyber defense.

HOW DOES IT WORK?

Hitachi Systems Security Inc.'s Governance Module was developed in order to:

- Give you the right tools to measure your risk and identify high-risk assets based on vulnerability scans and control settings
- Help you project future improvements by comparing various control maturity scenarios
- Evaluate your business group's most vulnerable assets and provide automated recommendations based on leading security best practices to mitigate your risks
- Provide you with a risk overview of your business systems (e.g. departments or processes running in your organization) by identifying their confidentiality, integrity and availability levels
- Drill down on your organization's current threats by business system devices group in asset types with the threat model view
